**SASOL awards to Corinth Pipeworks the contract for 76km of gas pipeline in  
Mozambique**

Corinth Pipeworks, steel pipe segment of Cenergy Holdings, announces that SASOL, an integrated energy and chemical company in South Africa, awarded a contract to supply 76 km of steel pipes for a gas pipeline in Mozambique to Corinth Pipeworks and its local partner, Project Materials Moçambique, SA.



The agreement covers approximately 76km of 8'' - 16'' High Frequency Welded (HFW) linepipe which will include external 3-layer polyethylene coating. The HFW pipes will be manufactured and coated at Corinth's facility in Greece and delivered directly to Mozambique within 2022.

This award is another significant milestone in Corinth Pipeworks' growing presence, as end-users are increasingly recognizing the benefits of utilizing Corinth Pipework's latest welded pipe technology for critical applications.
